

WHUR OFFICIAL SWEEPSTAKES RULES TO WIN A \$1,000 AAA APPLIANCES CERTIFICATE FROM WHUR TO SPRUCE UP YOUR SPACE

To enter, listeners of 96.3 WHUR radio ("Promoter"), from within the territory, must log on to the WHUR-FM website (WHUR.COM) to enter.
